William G. Conway: Curriculum Vitae

William G. Conway is a zoologist and conservationist who began his career at the Saint Louis Zoo as a volunteer in 1945. After graduating from Washington University, he became zoo curator of birds and assistant to the director. In 1956, he became associate curator of ornithology at the New York Zoological Society's (NYZS's) Bronx Zoo and eventually became curator of ornithology, associate director (1960), zoo director (1961), general director (1966), and subsequently its president. He stepped down in 1999 after forty-three years with the NYZS and was named senior conservationist.

Under Conway, NYZS grew to include a major International Conservation division, conducting more than 350 scientific and conservation projects in fifty-three nations, based on a team of outstanding field scientists. The society's facilities expanded from the Bronx Zoo, New York Aquarium, and Osborn Laboratories of Marine Sciences, to include New York's Central Park, Queens Zoo, Prospect Park Zoo, the St. Catherines Wildlife Survival Center in Georgia, and several overseas research stations. Its animal health program enlarged to provide wildlife overseas veterinary research and training services, while its education program expanded to provide environmental curricula in all fifty US states and fifteen other nations. The society's magazine, Wildlife Conservation, grew to serve other zoos, and the society's membership increased from 3,300 to 115,000. In 1993, to reflect its conservation focus, the NYZS changed its name to Wildlife Conservation Society (WCS).

Influence on zoos: Conway played a major role in the current redevelopment of zoos as proactive conservation centers and gave scores of papers at zoo and other meetings on the need for zoo conservation efforts. He led American Association of Zoological Parks and Aquariums (AAZPA) upgrading efforts, writing its first accreditation program—its widely copied Species Survival Program (SSP)—to sustain threatened species and zoo animal populations, and he founded its Field Conservation Program, which focuses zoos on in situ conservation.

In New York: Conway developed an exceptional team of zoo and field scientists, oversaw the development of more than twenty major New York zoo and aquarium exhibits, including the renewed Central Park, Queens, and Prospect Park zoos, the Aquarium's Sea Cliffs, the Bronx Zoo's JungleWorld, Wild Asia [Monorail], World of Birds, World of Darkness, Children's Zoo, Himalayan Highlands, and Ethiopian Baboon Highlands, and the innovative Congo Gorilla Forest, which gives its admission fees to the preservation of wildlife in their homelands. New departments included Exhibition and Graphic Arts.

Conservation in the field: More than fifty wildlife reserves were stimulated by NYZS/WCS projects during Conway's tenure, including programs in Africa, Asia, and South America. His personal efforts helped to establish more than a dozen wildlife reserves; national monuments and parks in Chile, Bolivia, the Falkland Islands, and especially in Argentine Patagonia. Conservation programs for flamingos, whales, dolphins, seals, sea lions, guanacos, penguins, and other sea birds resulted, along with the support and training of local scientists and conservationists.

Participation in conservation organizations: Conway is a past president of the American Zoo and Aquarium Association (AZA) and a current or past director of the American Conservation Association, Asa Wright Nature Centre (Trinidad), Caribbean Conservation Corporation, International Crane Foundation, Wildlife Conservation Society, Global Conservation Network of the International Union for Conservation of Nature (IUCN)/Conservation Breeding Specialist Group (CBSG), IUCN Flamingo Specialist Group, Asesor para Fundación Patagonia Natural (Argentina), Liz Claiborne Art Ortenberg Foundation, and a governor of the Society for Conservation Biology (of which he was a founder). He is also a past regional councillor of the IUCN and member of its Bureau, and he's a director of the Cornell Laboratory of Ornithology, World Wildlife Fund (United States), the National Audubon Society (NAS), the Edward John Noble Foundation, and the [Nixon] Griffis Foundation.

Honors received: Conway has received three honorary degrees, the Marlin Perkins Award of the AZA, the Heini Hediger Award of the World Association of Zoos and Aquariums (WAZA), the Gold Medal of WCS, "Commander of the Golden Ark" World Wildlife Fund (WWF) from Prince Bernhard of the Netherlands, Henry Shaw Medal of the Missouri Botanical Garden, the Audubon Medal of the NAS, the Conservation Medal of the San Diego Zoological Society, the Saint Louis Zoo Conservation Award, the Peter Scott Medal of the Survival Service Commission of IUCN, a special award from the Society for Conservation Biology (SCB), and the Distinguished Service Medal of the American Alliance of Museums (AAM). In 2000, the AZA created an endowed Conway Chair of Conservation and Science to help lead its zoo-based conservation efforts. Conway is also a Fellow of the Zoological Society of London (ZSL) and a recipient of the ZSL Award for Outstanding Contributions to the Zoo Community and of the Ulysses S. Seal Award of the CBSG of IUCN.

Publications: More than 250 popular and technical articles, books, and reports on wildlife conservation, demography, genomics, colonial species, natural history, zoological gardens, wild animal propagation, and zoo and conservation policy.
